## TABLE OF FEES EFFECTIVE FROM 1<sup>st</sup> September 2022

---

### INTRODUCTION

#### Fees and Payments

The following rules shall apply in relation to fees and payments:

- a) The fees and payments within paragraph 1, 2 and 3 below shall apply where the deceased was an inhabitant (see notes below) of Exning Parish and the Newmarket Town Council area.
- b) The fees and payments within paragraphs 1, 2 and 3 below shall be **DOUBLED** for all other applicants.
- c) It should be noted that the fees and payments within paragraphs 1, 2 and 3 below **EXCLUDE THE GRAVE DIGGING FEE** (see 'Grave Digger's Fees').

#### Notes:

1. For the purpose of this rule, "inhabitant" shall mean a person who, at the date of application or at the date of his or her death, had normally resided some time during the **three years** immediately prior thereto within Exning Parish and the Newmarket Town Council area.
2. The fees and payments may also be reduced when it can be proved to the Council's satisfaction that special circumstances exist which would warrant a reduction. The Council's decision will be final. In cases where a reduction is sought, the FULL FEES should be paid and WRITTEN application should be made for a refund once the funeral has taken place.
3. Residents who have moved out of the area through no fault of their own to a residential or nursing home are to be treated as though they are still an "inhabitant".

## INSCRIPTIONS

For the right to erect or place:

a) a flat stone **(in Exning Road Cemetery only)**

1) At ground level and covering a grave space of a superficial area of:

i) 7ft x 3ft [213cms x 91cms]

ii) for each additional adjoining space, an additional-

2) In any other form not exceeding 1ft, 6inches [45cms] in height, occupying a superficial area of:

i) 7ft x 3ft [213cms x 91cms]

ii) for each additional adjoining space, an additional-

*(Does not include foundations for kerbing and borderstones)*

b) a headstone or monumental book

**(in Laceys Lane Cemetery & Exning Road Cemetery)**

Not exceeding 3ft [91cms] in height

c) kerbstone or borderstone **(in Exning Road Cemetery only)**

1) Of 7ft x 3ft [213cms x 91cms] not exceeding in any part (including corner posts) a height of 12inches [30cms]

2) For each additional adjoining space occupied by kerbstone or borderstone, not exceeding in any part (including corner posts) a height of 12inches [30cms], an additional-

*(Cost includes laying of foundations for kerbing and borderstones)*

d) a monument in the form of: **(in Exning Road Cemetery only)**

1) a flower vase not exceeding 18inches [45cms] in height

2) a birdbath or scroll in similar form, not exceeding 18inches [45cms] in height or exceeding 1sq.ft [900sq.cms] and not exceeding 4sq.ft [3720sq.cms] in case area

3) in any other form, occupying a base area not exceeding 7ft x 3ft [213cms x 91cms]

e) any inscription after the first

On any monument or gravestone

f) memorial plaque 18inches [50cms] square secured on a plot for ashes

g) lacquered brass memorial plaque on the Council seat of remembrance

*(Please contact the Custodian: The Parish Council does not supply the plaque and the wording thereon needs approval)*

h) Fees for searches of registers and for copies and extracts to be taken therefrom:

1) Every search covering a period of not more than one year

40.00

*(Additional searches may incur an appropriate fee based on time)*

2) Every certified copy of an entry of burial in the register

40.00

*(Fees are at the discretion of the Cemetery Custodian)*
