At the meeting of the 30th October we established a deliverable way forward for the cycle path from Exning to Burwell. At this time I am unable to say more as it may jeopardise the projects delivery. However it is significant that there now IS an on-going project to deliver it and officers and resources allocated to the task. It has also been helpful that ECDC does not have the money to deliver the rights of way and legal side of their commitment to this, as it has been possible to allow FHDC and SCC to do it for them. Hopefully this will simplify the task and we have now gone to consultation. I am unable to say any more until land owners are fully consulted. Rachael Hood has been helpful in this endeavour and both of us strongly hope that the path will not only be a path and cycleway but bridleway as well and useful as a wider to link to Newmarket as much as Exning.
